

MH40 – STEEL POWDER COAT RECEIVING DESK







Construction

- Heavy gauge steel with powder coated finish
- 24"W x 22"D lift up lockable storage (4" minimum height)
- 14" x 24" writing surface
- Lock and key comes standard
- Convenient work area for organizing receiving and shipping operations
- Provides a large storage capacity, with lift up lockable storage compartment, and a large solid writing surface
- Available in Wall Mount, Stationery, Mobile or Mobile with Mesh Frame designs

Wall Mount Units

- Come with 2 Wall braces for additional support
- Some assembly required

Stationary and Mobile Units

- Come with 1" Square 16 Ga HRS powder coated tube frame
- 16 Ga bottom Shelf 8" off the ground
- 14" x 24" writing surface 42" off the ground

Mobile Units

- High quality polyurethane swivel casters for easy maneuvering
- Front casters have brakes to prevent movement while working

Mobile Mesh Units

- Expandable metal encloses base with lockable expanded metal door in front (Lock not included for mesh base)
- 2 16 Ga under shelves
